Management of Patients with Behavioral Health Afflictions/Ethics of Involuntary Sedation

Involuntary sedation, especially in the context of nursing, raises complex ethical issues that touch on autonomy, consent, and the role of healthcare providers. This presentation will explore the challenges in management of patients with mental health issues, discuss the ethics of caring for mental health patients and the concept of involuntary sedation. We will discuss the ethics of involuntary sedation in healthcare and the delicate balance between respecting patient autonomy and ensuring their well-being. Lastly, we will review ethical practice, which requires careful consideration of the principles of autonomy, beneficence, nonmaleficence, and justice, along with adherence to legal and institutional guidelines.
